

POWER OF ATTORNEY

ANTENUPTIAL CONTRACT INCORPORATING THE ACCRUAL SYSTEM

do hereby nominate, constitute and appoint ALLAN DAVID Mc NAUGHT or MARK LEATHERS or LEANNE AHLERS or JAYSHREE KISTENSAMY to appear before any Notary and to be our true and lawful attorney and agent in our name and stead to appear before a Notary and then and there as our act and deed to execute an Antenuptial Contract, declaring that whereas a marriage will be entered into between ourselves, we have agreed that:

1. There shall not be any community of property between us during our marriage;
2. There shall be no community of profit and loss between us during our marriage;
3. Neither of us shall be answerable for the obligations of the other whether contracted before or after the marriage;
4. All property acquired by or devolving upon either of us in any manner shall be the sole property of the party receiving it;
5. Each of us shall be at liberty to dispose of our individual property as we think fit;
6. Notwithstanding the foregoing, the Accrual system as set out in Chapter 1 of the Matrimonial Property Act 88 of 1984 shall apply to the marriage, save for the following specifications:
 - 6.1 No accrual shall lie at the instance of a spouse should such spouse's estate at date of dissolution of the marriage by death or divorce be de facto insolvent insofar as the spouse's liabilities exceed their assets, or should such spouse at the date of dissolution of the marriage be an unrehabilitated insolvent.
